



Coaching Disclaimer & Waiver: Assumption of Risk and Release of Liability

I hereby acknowledge and agree:

- I understand that all coaching services and communication (email, text message, on joyceereynolds.com, or otherwise) provided by Joyce Reynolds are meant to assist me with achieving my desired goals. I understand that comments and suggestions will be made that will help to identify areas in my life and in my thinking that may be preventing me from living the life that I desire. I can give my informed consent and, at this moment, give Joyce Reynolds permission to assist me in achieving such goals and aims.
- I understand that to the extent our work together involves career or business, Joyce Reynolds is not promising outcomes, including increased clientele, profitability, and business success.
- I understand that technology is not always secure, and I accept the risks of confidentiality in using email, text, phone, video calls, and other technology.
- I understand that Joyce Reynolds will protect my information as confidential unless I state otherwise in writing. Suppose I report child or elder abuse or neglect or threaten to harm myself or someone else. In that case, I understand that necessary actions will be taken, and my confidentiality agreement will be limited in this capacity. - I acknowledge that 24 hours is required to cancel appointments. For appointments canceled within 24 hours of my appointment time, I will be billed a \$20 cancellation fee.
- I acknowledge that these services and resources are not offered as a substitute for counseling, psychotherapy, psychoanalysis, substance abuse treatment, professional mental health care, medical care, or any form of therapy.
- I understand that coaching is not intended to diagnose, treat, or cure any mental health, addictions, or medical conditions. I also understand that Joyce Reynolds is not acting as a mental health counselor or a medical professional.
- I understand and agree that I am fully responsible for my well-being during and after my coaching sessions, including my choices and decisions. I agree to seek the help of a professional mental health counselor or a medical professional if I feel that I may be a danger to myself or others.
- I agree that Joyce Reynolds is not liable for my health or safety.

• I hereby release, waive, acquit, and forever discharge Joycee Reynolds, any agents, successors, assigns, personal representatives, executors, heirs, and employees from every claim, suit action, demand or right to compensation for damages I may claim to have or that I may have arising out of acts or omissions by myself or by Joycee Reynolds as a result of the advice given by Joycee Reynolds or otherwise resulting from the coaching relationship contemplated by this agreement.
